SUBJECT:

Recognition of Selected DOH Teaching and Training Hospitals as Regional Training Centers for the Establishment of Women and Children Protection Unit (WCPU) in Government Hospitals

Pursuant to Republic Act 9262 or the Anti-Violence Against Women and Their Children Act of 2004, the DOH is mandated to strengthen and/or establish WCPU in DOH Hospitals. Further, in accordance with DOH Administrative Order No. 2013 - 0011 or Revised Policy on the Establishment of WCPU in all government hospitals, there shall be at least one (1) WCPU in every province and chartered city.

In line with the Women and Children Protection Costed Implementation Plan 2021-2025, identified challenges and operational bottlenecks include the non-organization/establishment of WCPU due to lack of trained doctors, social workers, and service providers to provide quality, comprehensive, and more accessible medical care and assistance to victims-survivors of VAWC.

To date, 73 WCPU are lodged at hospitals in selected provinces/and cities nationwide. The DOH, in partnership with UP-PGH Children Protection Unit and Children Protection Network (UP-PGH CPU and CPN), has been providing technical expertise and training multidisciplinary teams in providing comprehensive medical and psychosocial services to women and children victims of gender-based violence. The DOH Teaching and Training hospitals are also being capacitated as providers of Women and Children Protection Specialty Training.

Therefore, based on the capability assessment and recommendation of the UP-PGH CPU and CPN, the following WCPU in DOH hospitals are recognized as Regional Training Centers for the establishment of WCPU in provinces/and chartered cities in the country:
